- Your cheque should be drawn on a personal account in the exact name as the applicant. For joint applications, your cheque should be drawn on a joint personal account in the exact names of the applicants. If this is not the case then a personal cheque from each applicant is necessary.

Where the surname and address given are both the same for all parties to the account, there is no need to obtain address verification for more than one of the parties.
