- An **Original Council Tax bill** at your current address for this current tax year
- Other **Original Personal Financial Statements** (credit card statement or another personal UK bank account) at your current address, dated within the last three months.

If your application is in joint names: We will need to see one form of original address identification document for each applicant from the list above. Where the surname and address given are both the same for all parties to the account, there is no need to obtain address verification for more than one of the parties.
